## CREDIT TERMS, PAYMENT PROCESS AND STORAGE FEE Updated 11/2024

### CREDIT TERMS

Clients with approved credit can place orders without a deposit, provided they are within their credit limit and electronically sign their estimate via SnapSign.

However, **full payment is required at the time of order pickup**. Orders cannot leave without payment in full.

### PAYMENT PROCESS OVERVIEW

**At Order Placement:** No payment is required if within your credit limit, and you must electronically sign the estimate to confirm the order.

**Order Arrival (3–4 Weeks Later):** Once your tile order arrives at Z Design, you will receive a notification. This period gives you time to invoice your clients and collect funds.

**At Pickup:** Payment in full is required to collect your order.

**Note:** If your order remains in our warehouse for 30+ days after notification of arrival, a full invoice will be issued. Payment will then be due within 30 days of the invoice date (60 days from order placement) or at pickup—whichever comes first.

### CREDIT ACCEPTANCE

Credit cards are an approved payment method for orders and services on COD accounts only.

### ORDER OVER \$7,000

A 3% processing fee will apply to the portion of any payment exceeding \$7,000. This applies if the total combined payments toward an order surpass \$7,000. (Example: For a \$10,000 order with a \$5,000 deposit and a \$5,000 final payment, a 3% processing fee will be applied to the \$3,000 portion of the second payment.)

### FEE-FREE PAYMENT METHODS

For all orders, including orders exceeding \$7,000, we encourage the use of checks, **ACH transfers, or other non-card payment methods** to avoid additional fees.

### TRANSPARENT INVOICING

The 3% processing fee for applicable transactions will be clearly itemized on your invoice for full transparency and record-keeping.

### STORAGE FEE

Orders left in our warehouse for **90+ days after notification** will incur a storage fee of \$50 per order, per month. This policy ensures a smooth warehouse workflow. We kindly request that all orders be picked up promptly.

## TERMS OF SALE AND ADDITIONAL INFO

### INVOICE SALES ORDERS AT 30 DAYS POLICY

Orders that remain in our warehouse for 30 days from the date they are received in full will be invoiced in full. Payment is required within 30 days of receiving the invoice.

### ADDITIONAL FEES AND CHARGES

**Packing Charge** – All orders are subject to a \$30 pack charge.

**Freight Charges** – Freight costs for tile shipped to Z Design will be added to most orders. Refer to the estimate/sales order for the quoted freight cost. Freight quotes are valid for 7 days and may be revised as necessary.

**Delivery Fees** – If you choose to have your tile delivered to your project, a separate delivery fee will be added to your sales order. The fee will be quoted and requires approval before being applied.

### ORDER INSPECTION POLICY

**Pickups** – a Z Design Tile and Stone employee will assist in inspecting the materials during loading to ensure accuracy. Clients should verify that the materials match the packing slip before leaving the premises.

**Deliveries** – it is the responsibility of the client or their authorized representative to inspect the materials upon arrival. Any discrepancies or damages must be noted at the time of delivery.

Z Design Tile and Stone is not responsible for issues reported after pickup or delivery without proper documentation.

### INSTALLATION CONSIDERATIONS

For best results, always refer to the manufacturer’s installation guidelines. The following general considerations are provided for awareness:

**Cement Products** – Many manufacturers recommend sealing with a topical sealer before grouting.

**Dark Grout** – Some manufacturers caution against using dark grout with cement products, as it may cause staining, even when sealers or grout release are used.

**Natural Stone** – Sealing before and after grouting is often advised.

**Crackle Tile** – Multiple sealant applications are required before grouting to prevent absorption.

**Test Samples** – Testing a sample tile before grouting is strongly recommended to ensure the final appearance meets expectations.

Z Design Tile and Stone does not provide installation recommendations and is not liable for installation outcomes. Always follow manufacturer instructions. Manufacturer guidelines are available upon request. The installation of the product signifies acceptance of the material.

### CLAIMS POLICY

Any broken tile must be reported to Z Design Tile and Stone within 24 hours of leaving the warehouse.

### RETURN POLICY

**Non-Returnable Items** – Grout, caulking (even unopened), custom or made-to-order products, hand-selected materials, and Arto products cannot be returned.

**Stocked Porcelain Tile** – One full, unopened box of stocked porcelain tile may be returned.

**Special Order Porcelain Tile** – Returns are accepted only if 10 or more unopened boxes of the same tile, size, and color are returned. Less than 10 boxes will not be accepted.

**Natural Stone Field Tile** – One full, unopened box may be returned. Partial boxes are not accepted.

**Mosaic Tile** – Must be returned in full boxes if purchased by the full box.

**Return Timeline** – All returns must be made within 30 days of pickup and authorized with a completed Return Materials Authorization (RMA) form.

**Return Condition** – Materials must be in original, resealable packaging. Returns must be properly packed to prevent damage. Broken, damaged, or installed tiles will not be accepted.

**Restocking Fee** – A 35% restocking fee applies to all returns, plus any freight costs to return items to the manufacturer.
